

Town of St. Armand
Public Hearing – Local Law No. 1 – Adoption of Rockledge Water Rules & Regulations – 6:00 pm
Tuesday, August 16, 2022

These Meeting Minutes were approved by the St. Armand Town Board on October 18, 2022.

A Public Hearing of the Town of St. Armand was held on the above date and time via webinar and in person conducted at the Town Hall, Bloomingdale, NY. The Meeting was advertised and made available to the public.

BOARD MEMBERS PRESENT:

Town Supervisor Davina Winemiller, Deputy Supervisor Karl Law, Councilperson Donald Amell, Councilperson Sheridan Swinyer, and Councilperson Stephanie Mikesell were present.

A quorum of the Board was in attendance.

TOWN EMPLOYEES PRESENT: Highway Superintendent Douglas Snickles, Wastewater Superintendent, and Town Clerk Barbara Darrah.

Supervisor Davina Winemiller called the Public Hearing to order at 6:00 pm and asked all to join in the Pledge of Allegiance. Supervisor Winemiller then asked Town Clerk Barbara Darrah to read aloud the Public Notice.
